<p><b>SECTION 7 - HANDLING AND STORAGE</b></p> <p><b>Safe handling procedures:</b>            Before handling, it is very important that engineering controls are operating, and that protective equipment requirements and personal hygiene measures are being followed. People working with this chemical should be properly trained regarding its hazards and its safe use. Do not use near welding operations, flames or hot surfaces. Handling equipment should be properly grounded. Inspect containers for leaks before handling. Label containers appropriately. Ensure proper ventilation. Avoid breathing dusts, vapours or mists. **Engineering controls:**
